Terms and Conditions for Awarding Christmas Vouchers

The Trustees are empowered under the Trust Deed to issue Vouchers to those who may need assistance with the costs associated with Christmas.

To comply with the Trust Deed

- Eligible persons must reside in the parish of Barton under Needwood
- There needs to be evidence of 'infirmity or disability or distress through illness, bereavement, accident or financial circumstances.' (Both short and long term circumstances may qualify)
- Neither age nor length of residence is on their own sufficient grounds for Trustees to make an award
- Vouchers may be issued to single, couple or family recipients
- No guarantee is given that a successful application means an automatic award in future years
- Trustees reserve the right to vary the value of the Vouchers
- The Trustees' decision on all applications is final and applicants accept that condition when making an application

Applications may be made by the recipient or by another person acting on their behalf.

It is the responsibility of the applicant (or the person acting on their behalf) to notify the Clerk to the Trustees of any change in circumstances which may affect future awards (e.g. moving away, change in family circumstance or bereavement of a recipient.)
